By engaging in any activities offered by, or associated with Campbellford and District Curling and Racquet Club/Meyers Sports Club, I freely accept and fully assume all inherent risks, dangers and hazards and the possibility of personal injury, death, property damage or loss resulting there from. I am aware that there are inherent and significant dangers, hazards and risks associated with the participation in the above mentioned activities. I am aware that risks include, but are not limited to, injury from physical contact with other members, performing a skill incorrectly, or potentially dangerous obstacles, conditions or equipment on the ice, vicinity, or floor of the facility. I understand that the risks are relative to my state of fitness or health (physical, mental or emotional), and the awareness, care and skill with which I conduct myself while participating in the above mentioned activities.

I acknowledge my obligation to inform the nearest employee of the Organization if I feel pain, discomfort, fatigue, or any other symptoms I might suffer during or immediately after my participation in the above mentioned activities. I understand that I may stop participating at any time, and have the right to immediately withdraw from any activity in which the conduct of any participant seems beyond the scope of the activity, makes me uncomfortable, or which I believe will be harmful to me.

Application: All athletes, coaches, members, volunteers, participants and family members of participants will be in attendance at club activities (“Participants”).

All Participants of Campbellford District Curling and Racquet Club/Meyers Sports Club, agree to abide by the following points when entering club facilities and/or participating in club activities under the COVID-19 Response Plan and RTP Protocol:

Check boxes below:

- I agree to symptom screening checks, and will let my club know if I have experienced any of the symptoms in the last 14 days.
- I agree to stay home if feeling sick, and remain home for 14 days if experiencing COVID-19 symptoms.
- I agree to sanitize my hands upon entering and exiting the facility, with soap or sanitizer.
- I agree to sanitize the equipment I use throughout my practice/play with approved cleaning products provided by the club (shared and personal equipment)
- I agree to continue to follow social distancing protocols of staying at least 2m away from others.
- I agree not to share any equipment during practice/play times.
- I agree to abide by all of my club’s COVID-19 Policies and Guidelines
- I understand that if I do not abide by the aforementioned policies/guidelines, that I will be asked to leave the club for up to 14 days to help protect myself and others around me.

Campbellford District Curling and Racquet Club/Meyers Sports Club – Squash Waiver

This waiver must be completed prior to visiting CDCRC/Meyers Sports Club and before participating in any activity. The club is taking every measure available to help ensure the safety of our members, however the below form must be read and signed prior to re-entering the facility.

The novel coronavirus, COVID-19 has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is known to spread mainly by person to person. Consequently, local, provincial, and federal governmental authorities recommend various measures. Working with our local health board and Squash Ontario, CDCRC/Meyers Sports Club has implemented several new mandatory rules for squash.

By signing this document,

1. I acknowledge the highly contagious nature of COVID-19 and I voluntarily assume the risk that I (or my child, if participant is a minor) could be exposed or infected by COVID-19 by participating in squash. Being exposed or infected by COVID-19 may particularly lead to injuries, diseases, or other illnesses.
2. I declare that I (or my child) is participating voluntarily
3. If I (or my child), or anyone in my household experiences any cold or flu-like symptoms I will not attend CDCRC/Meyers Sports Club.
4. If I (or my child), or anyone in my household has travelled outside of Canada in the past 14 days I will not attend CDCRC/Meyers Sports Club until at least 14 days since the date of return.
5. Prior to attending CDCRC/Meyers Sports Club I will use the online booking system to reserve a court.
6. Prior to entering CDCRC/Meyers Sports Club, I will respond to the self-screening form and send to campbellfordsquash@gmail.com
7. After each use of the squash court, I will sanitize all commonly touched surfaces (door handles, back glass).
8. I will not play any matches, or drills in the “Closed Court”, I am aware that this court is to be used for solo-hitting only
9. I will not play or drill with anyone who is not in my designated pod, and I will not play or drill with any member of a different club
10. I am aware that I am not to bring anyone into the club using my key-card.
11. I will not enter the sauna, weight-room, curling locker room, curling surface, or any other area of the club.
12. *I am aware that if I disobey any of the above guidelines, my membership will be suspended indefinitely.*
