This Rental Agreement is prepared between the Campbellford and District Curling and Racquet Club Inc.

herein after called “the Club” and _____ herein after called the “Lessee.”

The parties agree to the following:

- The Club agrees to having the Rental Space clean and ready for use on the agreed upon date and time
- The Club agrees to hanging the wall curtains, ceiling lights, and ceiling drapery on the Ice Surface Area
- The Lessee agrees to having NO confetti in the building, including table confetti.
- The Lessee agrees to having no vehicles on the Ice Area.
- The Lessee will not prevent reasonable access to the Club Members for other parts of the building not included in this agreement.
- The Lessee agrees to the Bar Closing Time of 1:00am.
- The Lessee agrees to have all people leave the building by 1:30am
- The Lessee agrees to purchasing a Special Occasion Permit and providing a copy of the permit to the club if they intend to provide their own table wine.
- The Lessee agrees to a corkage fee of \$3.00/bottle of wine if they provide their own wine
- The Lessee understands that if they chose to provide their own table wine, the Club’s bar must be closed until all wine is removed from the tables
- The Lessee agrees to ensuring all table wine purchased under their own permit is removed from tables before the Club reopens their bar.
- The Lessee agrees to having the Club’s bar staff fed by the caterer.
- The Lessee agrees to paying a refundable deposit to secure their rental date (\$50 for Bennett Lounge Rentals, \$100 for Ice Surface Rentals)
- The Lessee agrees to pay the Club for any damages to the building or equipment or severe mess
- The Lessee understands that their refundable deposit can be forfeited if the Lessee fails to comply with the terms of this agreement.
- The Lessee agrees to leaving the Rental Space as they found it, with the exception of floor cleaning
